


## INSTALLATION

**Note:** Mask and Visor accessories must be installed prior to fixture installation


1. Secure visor / masking shield to fixture mounting surface with (2) screws (by others) in straight line. centers of the visor / masking shield mounting slots align with the center of the fixture.



2. To avoid light leaks between visors / masking shields use light blocker bracket. secure light blocker bracket to fixture mounting surface with (1) screw (by others).



3. Proceed with fixture installation.
